**Dated Kohima the 27<sup>th</sup> July 2019**

**SUB: COMMISSION ON RIIN.**

**No. CON-3/PAP/65/10:** Whereas Government of Nagaland issued Notification of even number dated 29<sup>th</sup> June, 2019 for creation of Register of Indigenous Inhabitants of Nagaland (RIIN);

2. And whereas, subsequently, views, opinions and concerns have been expressed by various sections of civil society and tribal bodies of Nagaland on a number of matters pertaining to the exercise for RIIN. Several pertinent issues concerning RIIN were also raised in the two consultative meetings held by the Government with various tribal bodies, civil society groups and representatives of various communities of the State;
3. Therefore, with an objective for studying, examining and recommending and advising into all issues relating to RIIN, Government of Nagaland hereby constitutes a Commission under the Chairmanship of Smti. Banuo Z Jamir, IAS (Retd).
4. The members of the Commission will be as follows:
  1. Smti. Banuo Z. Jamir, IAS (Retd) - Chairperson
  2. Shri. T. Kiheto Sema, IAS (Retd) - Member
  3. Shri. C. Shingwang Konyak - Member
5. Justice Zelre Angami (Retd.) will function as the Advisor to the Commission
6. Home Commissioner Nagaland shall be ex-officio Member Secretary of the Commission and Commissioner, Nagaland and Secretary, Law & Justice will be ex-officio members of the Commission.
7. The support in the form of manpower/logistics/funds for smooth functioning of the Commission shall be provided by the Home Department of Nagaland.
8. The Terms of Reference of the Commission, in relation to Para 3 above, will be as below:
  - i. Eligibility criteria to be an Indigenous Inhabitant
  - ii. Authority to authenticate claims of being Indigenous
  - iii. Place of registration as Indigenous Inhabitants
  - iv. Basis of claims of being indigenous
  - v. Nature of documents that will be acceptable as proof for being Indigenous



- vi. Any other issue relating to implementation of RIIN including the manner in which the exercise is to be carried out
9. The Commission will chalk out the modalities for carrying out its work in the manner it deems fit.
10. The Commission shall have access to all records and documents that may be relevant to the subject and shall also be free to associate any Government official or any person as it may deem fit for successful completion of the task assigned to it.
11. The Commission shall submit its report within three months from the date of its constitution.
12. The details of the remuneration /honorarium of the members of the Commission and the Advisor will be notified separately.
